Flavor

This tasty melon defies classification – part Cantaloupe, part Galia, all flavor! Sure to be a favorite at local markets, this variety is sweet, juicy and ripens earliest in its class. Divergent has consistently received top scores in taste tests for its delicious, unique flavor combined with an appealing texture.

Grower Friendly

A top performer under organic conditions! Medium-sized, round fruits set close to the crown for a concentrated harvest. Plants are vigorous and healthy, with large leaves that protect fruit from burn. Vines also hold up well against powdery mildew. Quick to mature, this variety can be

completely harvested in 2 to 3 passes. Succession plantings are recommended for a continuous supply throughout the season. Divergent is also a top choice for home gardeners wanting a strong, easy to grow melon with old fashioned taste.

Uniformity & Adaptability

This specialty cantaloupe is notable for its uniformity, both in maturity and fruit appearance. The exterior netting is low and fruits look similar to a Galia melon from the outside. Fruits are ready to harvest when the exterior color changes halfway from green to tan. Divergent is an adaptable, high yielding variety that performs well in many regions, including Northern areas with shorter seasons.
